### **2.1 Sectoral**

At the E3 and S8 tables, on regional disparities, we are only discussing the food transport allowances. The employer does not have the will to propose anything else until we settle this issue. What the employer offers is clearly inferior to the real costs, which would be a loss for our members that use their allowances, as well as a loss with the actual dispositions of the collective agreement. Our negotiation teams do not feel the will of the employer to settle the negotiations rapidly, no matter what they say. Considering the differentiated financial frame obtained by the Board, it is incomprehensible why the negotiations do not progress more smoothly.

## **2.2 Action-Mobilisation**

Tarek Khazen introduced the item.

There should have been a meeting with the persons responsible of action-mobilisation (RAM) of the Centrale, the federations and of the AENQ, but no invitation what received. Our RAM will make sure that this meeting takes place soon.
