1. Presentation of the Agenda

Larry Imbeault presented the closed agenda (Appendix 1).

2. 2020 Negotiations

2.1 CSB

Larry Imbeault introduced the item.

There were no bargaining meetings with the MNCCSB during the Goose Break. A negotiation meeting is scheduled at the E3 table tomorrow, May 17th, and at the S8 table on May 19th.

2.2 Action-mobilization

Tarek Khazen introduced the item.

During the Goose Break, a meeting of the people responsible for Action-mobilization (RAM) at the Centrale, the federations and the AENQ took place and a mobilization action plan was prepared.

There will be a demonstration in front of the CSB head office in which Tarek Khazen, Paul Washipabano and Luc Lefebvre (members of the Executive Committee) will participate; Marie-Julie Laniel Corriveau who is soon to become a member of the EC will be present as well. A meeting with the AENQ members will take place in the high school gym the day before to inform them of the gains made for our KSB members. Audio messages will be broadcast, either on the regional radio or on social networks. Also, there is a meeting of the CSQ General Negotiating Council (GNC) in Quebec City scheduled for May 26 and 27, 2022. In the course of these proceedings, the GNC delegates will stage a demonstration during the 90-minute strike. There will be speeches and the media will be addressed. Regional coordination teams concerned will deploy CSQ members to picket outside the offices of Sonia Lebel (President of the Treasury Board and Responsible for sectoral negotiations) and Ian Lafrenière (Minister Responsible for Indigenous Affairs).

Motion 1

Considering the following decision taken on April 25: "That the AENQ members who work for the CSB call a 90-minute strike on Thursday, 26 May 2022, in coordination with the professionals (to be conferred at the NNCC–CCSNN joint meeting on May 2) and that the strike notice should be sent out during the Goose Break";

Considering the Regional Annie Whiskeychan Day;

Considering the action-mobilization plan put in place which takes into account this special day;

It was moved by Larry Imbeault and seconded by Tarek Khazen

THAT Strike notices be sent on 16 May 2022, so that the strike originally scheduled for May 26 take place on May 27 from 9:30 to 11:00 a.m.

UNANIMOUSLY ADOPTED

Motion 2

It was moved by Larry Imbeault and seconded by Tarek Khazen

THAT Strike notices be sent out on 30 May 2022 for a 3-day strike to take place on 9, 10 and 13 June 2022.

UNANIMOUSLY ADOPTED

Motion 3

It was moved by Larry Imbeault and seconded by Tarek Khazen

THAT The monetary compensation for the 90-minute strike on May 27 be set at \$65 for those participating in the demonstrations.

UNANIMOUSLY ADOPTED

Motion 4

It was moved by Larry Imbeault and seconded by Tarek Khazen

THAT The monetary compensation for the 3 strike days on 9, 10 and 13 June be set at \$200 per day for those participating in the demonstrations.

UNANIMOUSLY ADOPTED

Motion 5

It was moved by Larry Imbeault and seconded by Tarek Khazen

THAT The AENQ make available to the regional coordination teams involved in the demonstrations, to be held outside the offices of Sonia LeBel and Ian Lafrenière, a sum of up to \$5,000 from the strike fund.

UNANIMOUSLY ADOPTED

The meeting was adjourned at 6:30 p.m.
