5. Recognition of Union Members' Work

Daniel Charest suggested that the AENQ recognize the union involvement of members, somewhat like employers do, with the awarding of a gift after, for example, 5 years, 10 years or 20 years of union work within the AENQ, either as a staff delegate or as a substitute delegate, a member of the Executive Committee or an office staff member. A decision will be made at a future meeting.

6. Donations

Daniel Charest introduced the item.

Considering the surpluses of money generated in the last years, Daniel Charest proposed that we increase the amount allocated for donations. Since there is no urgency to settle this point and considering that it is already 8:00 p.m., the time

scheduled for the adjournment of the meeting, we all agree to postpone the decision until the next meeting.
