# 1. Presentation of the Closed Agenda

Angela Tripp presented the closed agenda (Appendix 1).

#### 2. 2023 Negotiations

#### 2.1 Strike Mandate

Larry Imbeault introduced the item.

- Confirmation of private confidential information;
- Negotiations not going well;
- Gave position on each demands and which ones we were open for discussion;
- Intersectoral negotiations are also not going well, or at all;
- Strike mandate is in discussions:
  - Unlimited strike is not off of the table;
  - Shorter strikes would be to start;
    - i.e. 90 mins, followed by 2-3 days, then unlimited;
  - Should members vote in favour of a strike vote we would discuss what to do with strike funds;

- However if the members vote against the strike, they will have to vote on a rally vote;
- A Nego-Newsletter will be sent out soon to inform the members.

# 2.2 Action-Mobilization

Tarek Khazen introduced the item.

- 80% of materials (banners, posters, scarves, whistles, etc.) have been received by the union;
- Looking at when it would be sent to the schools (awaiting new representatives' information);
- In a previous email was listed the mobilization plan of action:
  - This is a provisional plan that starts with visibility actions and is progressive;
  - Every Tuesday we wear the armband, Thursday we wear the headband, posters in the school in English, Cree, Inuktitut or French;
  - There will also be banners and flags to be planted outside, these are kept for other times, and the Sector Director will be notified when to use them;
  - After the visibility phase we move to disturbance. This is a time of action, visibility as well as distributing things in the school (work to task and nothing extra, not signing the declaration day forms, etc.);
  - What is important for now is to send all of the materials to the schools. When the members received them and have distributed to members then more information will be given on when to use them.

# 3. Women Status Committee

Larry Imbeault introduced the item.

- It was mandated to keep the women status committee at the last Congress.
- It was decided that the Executive Committee representative of the committee will be a woman.

- THAT Guillaume Lajeunesse be, when needed, Larry Imbeault' substitute at the meetings of the FSE Federal Councils, and therefore at the meetings of the General Council of Negotiation.
- THAT Paul Washipabano be, when needed, Tarek Khazen' substitute at the meetings of the FPSS Federal Councils and Negotiation Federal Council, and therefore at the meetings of the General Council of Negotiation.

# UNANIMOUSLY ADOPTED

#### 5. Support Staff National Day

Tarek Khazen introduced the item.

- Executive Committee members received the information from Tarek Khazen in an email;
- September 28<sup>th</sup>, 2023, all support staff that belong to the FPSS will celebrate;
- The AENQ, Cree School Board and Kativik School Board will participate but outside of school hours;
- There was a meeting last week with Paul Washipabano, Tarek Khazen and Tuniq Makiuk discussed doing a BBQ:
  - Estimated about 500 support staff members and calculated \$40.00 per person;
  - Money will be sent to delegates 5 days before the event, no one should be waiting on cheques;
  - Receipts need to be sent back to the AENQ as soon as possible.
- Visuals well be sent out and photos of the event are requested to be sent to AENQ;
- One teacher per school/center will be asked to express their gratitude towards what the support staff do in their school. These will be posted on the AENQ Facebook Group;

- Tarek Khazen will also post a letter of gratitude for the support staff on the AENQ Facebook Group;
- Information on this activity will be sent out in the next few days;
- Marie-Julie Laniel-Corriveau and Guillaume Lajeunesse will gather testimonies from staff to put on the AENQ Facebook Group.
- Many representatives have not been elected yet, Tarek Khazen suggested that they start with the ones that are elected because if they wait it could be too late to get them in time.

THAT the meeting take place in Montreal September 24<sup>th</sup>-26<sup>th</sup> with travel days being the 21<sup>st</sup> and 22<sup>nd</sup> and 27<sup>th</sup> and 28<sup>th</sup>. Keeping in mind of the demonstration of September 23<sup>rd</sup>.
